- Shri P.M. Prasad, President, MGMI, who could not be physically present due to pressing assignments, delivered his address virtually from Ranchi. Hard copies of the presidential address were circulated to the members present in the hall. While welcoming the participants, Shri Prasad said it had been an honour for him to be the President of a century old organization and he took this opportunity to thank each and every member of MGMI. He mentioned that after completing 75 years of independence, India had entered "Amrit Kaal' which will last till 2047. India has overtaken the ex-colonial masters to become the fifth largest economy of the world. According to him, energy use and access is closely related with economic development. Energy option of India is very limited. Domestic production of oil and natural gas has declined considerably during the last ten years. This is increasing onus on coal to meet the energy and resource security of the nation. Circular economy is a way to conserve resources. India's material recycling rate stands at 30%. Metal sector needs to be at the forefront of the circular economy following 6R principles of Reduce, Recycle, Reuse, Recover, Redesign and Remanufacture. If India is to grow into a \$5 trillion economy, Geology, Mining, Metallurgy sectors have a big role to play and this is where MGMI comes in.

The President talked of the 9th Asian Mining Congress and International Mining Exhibition held in April 2022 which was an effort to be back to normalcy by being the first such physical event in Mining sector organized in India after the pandemic induced disruptions. This event was a grand success with participation by more than 250 professionals and 180 companies. Top government functionaries and Industry leaders spoke during the conference and a number of enlightening papers were presented. He also mentioned about the 17th Foundation Day lecture delivered by Prof S P Banerjee. He praised the editorial board of MGMI led by Dr A K Singh for the quality, contents and timely publication of the MGMI News Journals.

He thanked S/Shri Ranajit Talapatra, Rajiw Lochan, Prasanta Roy and the Chairman and members of various committees for their yeoman services in making the 9th AMC and IME a grand success. The President also thanked numerous organisations and individuals who had helped to make his tenure gratifying and successful. He wished a bright future for the organization.

- The Secretary announced that in the last Council Meeting, it was unanimously decided that Dr B Veera Reddy, Director (Technical), Coal India Limited, will be the next President of MGMI and that he has kindly accepted the post. The incoming President was requested to grace the dais and was felicitated by Shri R P Ritolia with a flower bouquet and the traditional president's collar was presented to him by Shri V K Arora.
- As per the agenda, the report of the Board of Scrutineers on the Election of the Council Members for the years 2022-25 was presented by Sri R K Saha, Chairman, Scrutineers Committee. He read out the names of 11 successful candidates, which are Dr.Amalendu Sinha, Dr. Prabhat Kumar Mandal, Shri J.P. Goenka, Shri Peeyush Kumar, Shri Awadh Kishore Pandey, Prof. Ashis Bhattacherjee, Shri Tapas Kumar Nag, Shri V K Arora, Dr Jai Prakash Barnwal, Prof G P Karmakar and Shri J V Dattatreyulu. He informed that 375 votes were cast in the online election and congratulated the winners. He and Shri J P Goenka also took special mention of the way the e-voting was organized at a short notice almost wholly by the Honorary Secretary and lauded his initiative and hard work to reach as many members as possible and following up.
- The General Body agreed to the Honorary Secretary's proposal of modifying the Articles of Association of MGMI to include e-voting as a default process, unless otherwise, with a 15 to 30 days' window for voting to ensure maximum voting.
- Shri J P Goenka invited the new President to say a few words. While thanking the
  members for choosing him as the President of the prestigious organization, he
  said that he feels it is a big responsibility and will need guidance of the experienced

members. He congratulated the award winners and newly elected council members.

 S/Shri V K Arora, S P Banerjee and Prasanta Roy thanked the Past President, Council members for guidance in the activities of MGMI. Shri N C Jha, Past President welcomed Dr. Reddy and suggested to involve social media for publicity of MGMI. He felt basic purpose of MGMI is to disseminate knowledge and regular webinars may be arranged. Sri R P Ritolia desired that the Branches be revived.

The meeting concluded with Vote of Thanks by Shri C S Singh, Honorary Jt. Secretary. He thanked the Past President, Secretary, Council Members, all members who helped in MGMI activities and the staff members of the Institute.

#### HIGHLIGHTS OF 893rd COUNCIL MEETING

The 893rd Council Meeting of MGMI held at MGMI Bldg, GN-38/4, Sector - V, Salt Lake, Kolkata-700 091 on **29th May 2022**, at 12.30 p.m.

Shri P M Prasad, President (virtually in the Chair). The meeting was attended by Prof Sakti Pada Banerjee (present virtually), Prof. B B Dhar (present virtually), Shri R P Ritolia (present virtually), Shri R K Saha, Dr. N K Nanda (present virtually), J.P. Goenka (present virtually) S/Shri Ranajit Talapatra, Chandra Shekhar Singh, Prasanta Roy, Rajiw Lochan, Dr. Ajay Kumar Singh, T K Nag, Smarajit Chakrabarti, N N Gautam (present virtually), Bhabesh Chandra Sarkar, Prof Netai Chandra Dey, Prof G P Karmakar (present virtually), Dr. J P Barnwal (present virtually), V K Arora (present virtually), I P Wadhwa from Tafcon (present virtually).

The Minutes of the 892nd meeting of the Council held on physical and virtual platform at MGMI Bldg. Kolkata–700 091 on 27th February, 2022 at 12.30 p.m. was confirmed.

The Council considered the Action Taken Report in respect of the Minutes of 892nd Council Meeting held on 27th February 2022 (on hybrid mode).

#### 9th Asian Mining Congress (April 4-5, 2022)

 On being requested by the Honorary Secretary, Shri Prasanta Roy, Convenor of Exhibition Committee of 9th IME invited Shri I P Wadhwa, Managing Partner, M/s TAFCON to apprise the Council about the 9th IME.

- Shri Wadhwa briefed the Council about 9th IME and mentioned that he never expected such good participation in the 9th IME. The Stall booking was as good if not better as previous years and ultimately it was a grand success with the help of the President MGMI, Chairman 9th IME and Council Members. It was informed that Rs.12 Lakhs have already been paid by Tafcon in 2 instalments of Rs 6 lakh each as per MOU. The Council thanked Mr Wadhwa & the Exhibition Committee for the achievement.
- Shri Rajiw Lochan, immediate Past Secretary, appealed to the Council Members and Shri I.P. Wadhwa, Managing Partner, Tafcon to increase the guaranteed money from Rs. 35 lacs to Rs. 55 lacs. He gave the reason that in the 8th AMC guaranteed amount was fixed at Rs. 45 lacs. So, as per usual MOU the minimum guaranteed money should have been increased by 10% from the last AMC which comes to Rs.50 lacs. However, on repeated appeals by Sri Wadhwa to consider the downward sentiment of the industry due to the pandemic, the Council agreed to reduce the guaranteed money from last AMC with the rider that in case the Exhibition was successful, the amount will be increased by Tafcon as per normative calculation of square feet or 10% whichever is more. But in Mr Wadhwa's own words, 9th IME has been unexpectedly successful, and in the words of Sri Prasanta Roy, Convener, Exhibition, best in a few years. Considering that business has been good for M/s. TAFCON in spite of Covid apprehensions, Shri Wadhwa was requested to increase the guaranteed money. Shri Wadhwa assured that this proposal will be taken care of with mutual discussion with MGMI Management in person.
- Sri Rajiw Lochan apprised the Council that 9th AMC again was an unexpected success with about 320 participants over the 2 days. He informed that CIL, NCL, BEML, SCCL & NTPC sponsorship amounts have been received. He took pleasure in intimating that going by conservative estimates of dues from delegates and Tafcon (@35 lakhs), the total income is expected to cross Rs 1.6 Crores, whereas the expenditure (including the proposed printing and despatch of Proceedings volume) is expected to be 86-87 lakhs, resulting in a net saving of about Rs 73-74 lakhs, which will increase if realisation from Exhibition is improved.
- The council unanimously agreed that the organisation of 9th AMC was wonderful with very good Brand visibility & financial benefit for MGMI, and congratulated the Conference Committee for the accomplishment.

## **Holding of Foundation Day Lecture**

 The Honorary Secretary informed that the Foundation Day Lecture will be delivered by Prof. S. P. Banerjee, Former Director (In-charge), ISM Dhanbad and Past President MGMI. Regarding the date of Foundation Day Lecture, the Council authorized the Hony. Secretary to discuss with Prof. Banerjee and decide about the date, preferably 25th or 26th of June 2022 as Prof Banerjee will be leaving for Australia on 27th June 2022.

# 1/2 day Seminar / Workshop and AGM in September 2022

• The ½ day Seminar/Workshop, Holland Memorial Lecture and AGM was proposed to be held tentatively on 25th September, 2022.

#### **Membership Drive**

 The Honorary Secretary informed that six applications have been received for Life membership and one application for Student Associate Membership of MGMI. All the applications have been considered and approved by the Council and accordingly, they will be intimated of their enrolment with membership nos.

Alongside, Honorary Secretary informed that he has already taken some initiative on membership drive and in this connection, he has talked with CMD, NCL, and CMD, CCL for concerted drives in NCL & CCL respectively.

# MGMI Journal and Proposals for Scopus Indexing

The Honorary Secretary requested the Honorary Editor to apprise the Council about the progress made in this regard.

The Honorary Editor informed that a meeting of the Editorial Board was convened on 2nd May 2022. He spoke about the need for Scopus Indexing of the Transactions the placed the following information:

- a) Scopus is a leading indexer of scholarly research with impressive global readership & published journals are added to indexing databases for wider reach.
- b) There is no cost to being included in Scopus.
- c) There is a rigorous selection process overseen by its Content Selection and Advisory Board (CSAB), which is an international group of scientists who are experts in their respective subject areas.

To qualify for consideration by the Content Selection and Advisory Board (CSAB), the journal must

- Publish peer reviewed content and have publicly available peer review policies/ processes listed on its website/webpage.
- (ii) Have a website/webpage.
- (iii) Include references in Roman Script.
- (iv) Have ISSN International Centre registration.

- (v) Have publicly available publication ethics.
- (vi) Journals have a 2+ Years history of publication.

The Honorary Editor summarized the necessary steps need to be taken immediately as under:

- The Editorial Board to be extended by including Prof. Keka Ojha, Head, Department of Petroleum Engineering, IIT (ISM) Dhanbad, Prof. Khanindra Pathak, Department of Mining Engineering, IIT Kharagpur and Prof. A. K. Verma, Department of Mining Engineering, IIT BHU, Varanasi, who are all Life members and have consented to be in the Editorial Board of MGMI.
- 2. The journal to have a webpage with publication template that will be single point for submission of manuscripts, with a dedicated webpage with a link/button on the MGMI Homepage Dashboard.
- 3. Peer review policies/processes should be prepared after extending the Editorial Board and it will be uploaded on the webpage of the journal.
- 4. Publication ethics will also be formulated and made public by uploading on the journal's webpage.
- 5. The journal to have ISSN No.
- 6. Papers published in last 3-4 years to be uploaded on the webpage of the journal.

These steps were agreed to by the Council, and after detailed deliberation, it was decided to publish as many peer reviewed papers as possible in the journal and MGMI should go ahead to apply for the journal indexed in Scopus.

The discussions also included the need to retain the long-standing tradition of the Institute's transactions facilitating wide circulation of mineral / mining field oriented notes and papers from practicing engineers and professionals, including those presented at the local chapters of the Institute, so that the related industries can benefit from experiences and developments in different parts of the country. It was agreed that such contributions from the industries concerned would continue to be encouraged and adequately covered.

It was proposed by Honorary Secretary that a Finance committee may be constituted for the purpose of matters of finance including manpower. The names of Shri V.K. Arora, Shri R.K. Saha, Dr. Amalendu Sinha and Shri Prasanta Roy was proposed for the committee with Honorary Secretary as the ex-officio member. The proposal was accepted by the Council.

The Honorary Secretary requested the President to formally close the meeting with a few words. The President thanked all present in the meeting once again for sparing their valuable time and taking part in the deliberations.

Jha, R K Saha, Dr. N K Nanda (present virtually), Anil Kumar Jha (present virtually), J P Goenka, Ranajit Talapatra, Chandra Shekhar Singh, Prasanta Roy, Rajiw Lochan (present virtually), Dr. Ajay Kumar Singh, T K Nag, Smarajit Chakrabarti, Dr. Amalendu Sinha, Dr. Kalyan Sen, Anup Biswas, Prof Bhabesh Chandra Sarkar, V K Arora, Dr. J P Barnwal (present virtually), G.P. At the outset, Honorary Secretary pointed out that this will be the last Council Meeting of Sri P M Prasad, as President, MGMI and profusely thanked him for his help, accessibility and pro-active contribution in passing through the Pandemic years, as well as the grand success of the 9th AMC and 9th IME.

President, MGMI acknowledged the help he got from the Council and the office bearers during his tenure and assured his help even after his relinquishing this high MGMI office.

- The meeting was then called to order by the President. The President welcomed the members present physically and virtually. Thereafter, President requested the Hony. Secretary to take up the Agenda for deliberations.
- To confirm the Minutes of the 893rd meeting of the Council held on physical and virtual platform at MGMI Bldg., Kolkata–700 091 on 29th May, 2022 at 12:30PM
- The Minutes were circulated to all the Council Members earlier. Since no comments were received, the Council resolved that: The minutes of the 893rd Meeting of the Council held on 29th May, 2022 at 12:30 PM on physical and virtual platforms, is confirmed.

#### To consider matters arising out of the Minutes.

• Shri R.P. Ritolia, Past President wanted to know the advantages of Scopus Indexing of Transactions. The Honorary Editor replied that there are various types of indexing of which Scopus Indexing may be considered as the base level of indexing. This is required for better citation of the papers published for which most of the Authors are interested in. Without such indexing Authors may not be interested to contribute a technical paper for the Journal. Prof B. C. Sarkar opined that this should be the

minimum requirement for publication of a scientific journal in present days. Prof. S.P. Banerjee, Past President was also of the opinion that Scopus Indexing is a must for existence of the Journal. Shri Smarajit Chakrabarti wanted to know if the papers contributed by the practicing Engineers and Geologists from the field would find a place in the Transactions after Scopus Indexing. The Honorary Editor apprised that all papers, be it from the field or from the academia are welcome and would be published after peer review of the same. The authors will be requested to revise their paper as per the reviewers' comments. Therefore, the papers received from the field may also be published after accepting the reviewers' comments or rejecting the same with proper justification. Dr. Kalyan Sen also supported the idea of Scopus Indexing of Transactions. It was finally agreed that we should go for Scopus Indexing of Transactions and the Honorary Secretary agreed to provide all necessary help such as having a dedicated button for the Journal on MGMI Website and enabling Journal Management System in near future.

# To inform the Council about roadmap and progress in respect of E-voting Process

The Honorary Secretary of MGMI informed the Council regarding progress in respect
of E-voting Process that MGMI published notification in 2 renowned all India based
daily newspapers on 29th August, 2022 for intimation to the members of MGMI.

The Council approved the re-appointment of M/s. Jha & Jha, Chartered Accountants as Auditors of MGMI for the FY 2022-23 at an increased remuneration of 15,000/- (excluding applicable taxes) instead of Rs. 12,000/- (as per their request letter to increase remuneration) for execution of all assignments of Audit, ROC, Annual Filing, IT Returns etc.

#### To elect the President of the Institute for the year 2022-23

The name of Dr. B. Veera Reddy – Director (Technical), Coal India Ltd was proposed for President, MGMI for 2022-23 by Sri J P Goenka and seconded by Sri Prasanta Roy. The Council was pleased to agree.

### To consider and approve the recommendations of Finance Committee

Honorary Secretary read out the deliberations during the 2 Finance Committee meeting and the recommendations.

- There were three permanent employees and four contractual employees in the
  office of MGMI. It was recommended to increase the remunerations of the
  Permanent employees as per standard practice and the last salary hike of the
  MGMI staff, both permanent as well as contractual, was done in April 2017, more
  than 5 years ago. The salaries of two contractual staffs are recommended to
  continue at same level till further decisions.
- 2. Another contractual employee will retire after 30th September due to old age.
- The present Executive Secretary Shri G Ghatak who is also a contract employee is suffering from ill health and will retire.
- A newspaper ad was published for an Executive Secretary. The applications are being screened and the shortlisted candidates will soon be called for an interview to choose the best candidate.
- 5. A consolidated salary of Rs 30000/- was recommended, which may be increased up to Rs 45,000/- for an exceptionally suitable candidate.
- Medical Allowance to remain at the same level (one month's salary, paid quarterly
  in equal installments over the year) to only the permanent employees, as is the
  practice now.
- It was suggested that a Medical insurance (Group or Individual) of a moderate coverage, may be explored for the Staff, including the contractual employees and may be implemented.
- Members who attend from areas within city limits (Howrah city included) or 50 Kms from MGMI office, will be limited to Rs 700/-, without need of receipts. Presently it is Rs 300/-.

Members who attend from areas beyond the above - Rs 5000/- or actual, whichever is less.

Tickets, receipts, etc., will be needed in such cases. Presently it is Rs 3000/-.

Honorary Secretary informed the Council of the passing away of Shri Lab Kumar Bose, former Honorary Secretary, MGMI (1995-1999) on 9th March at his residence at Kolkata after almost a year of age-related illness. He was 84 and left behind his wife, two daughters and a grandson.

A solemn one-minute silence was observed in respect to the departed soul and thereafter, the Council Members were requested to speak about their interactions and memories of Late L K Bose.

Several members paid glowing tributes to Late Bose, one of the very active and contributing members of MGMI. It was informed that it was during his tenure as Honorary Secretary, that the present MGMI Building at Sector V was built. Prof. S.P. Banerjee informed that it was Late Bose who prepared the master plan of creation of Eastern Coalfields Limited when he was working in Coal India Limited.

Shri V K Arora recommended that Late L K Bose's contribution to MGMI be recorded and a resolution passed to send across to his grieving family expressing sincere condolences. The resolution was passed with several members supporting the recommendation.

President promised that whatever help is required by the family at this juncture, MGMI members will help.

The President welcomed the Past Presidents, Past Honorary Secretaries, Present Honorary Secretary, Chapter Chair Persons and existing Council Members who were present physically as well as virtually in the meeting.

He informed all members about the good work started by the local chapters, like Hyderabad, Odisha, Delhi and Nagpur. The Nagpur Chapter organised a seminar on 12th March, 2023.

He talked at length about his vision for MGMI and the targets including making MGMI more meaningful all over the country. He introduced the Chairman, Nagpur Chapter, Shri Anil Kr Singh, Director (Technical), Project & Planning, WCL as the main man behind the seminar being organised by MGMI Nagpur Chapter the next day on 12th March, 2023 and reminded that senior members like him are coming back to MGMI Council and enriching it. It was informed that in the past, Sri Singh was the Honorary Secretary of Odisha Chapter and a Council member too.

# Confirm the Minutes of the 896th meeting of the Council held in Hybrid platform at MGMI Hq, Kolkata on 03rd December, 2022.

The 896th Council Minutes were circulated to all the Council Members. As no comment was received, the Council resolved that: The Minutes of the 896th (2nd meeting of the 117th Session) Meeting of the Council held on 03rd December, 2022 at 11.30 AM on Hybrid platform, be confirmed. The Council considered the Action Taken Report in respect of the Minutes of 896th Council Meeting held on 03rd December, 2022 on virtual platform and concurred.

# Discuss about the 10th Asian Mining Congress and Exhibition.

#### Shri Prasanta Roy – Convenor of the Conference highlighted the points as below:

In the last Council Meeting, the Organizing Committee & Exhibition Committee were finalized and subsequently an Organizing Committee Meeting was held in which a Technical Committee was constituted.

A Technical Committee meeting was held subsequently and a draft brochure has been prepared.

Important dates related to "Call for papers" were proposed—

Abstract submission – by 31st May 2023
Abstract acceptance notification – by 15th July 2023
Full paper submission – by 1st September 2023
Full paper acceptance notification – by 13th October 2023

He informed that letters have been sent for logo support to different Ministries and Secretaries of Heavy Industries, Power, Steel, etc., but till date, responses are awaited other than The Ministry of Coal, who has consented for logo support and Secretary (Coal) as Patron. It was proposed to wait for few more days to see if any other Ministry provides Logo Support, before sending the Brochure for printing.

He requested Shri Peeyush Kumar to follow up with other Ministries, who agreed to do the same.

Convenor, Conference read out the sponsorship rates of the 9th Asian Mining Congress and informed that the rates have been kept the same for 10th Asian Mining Congress.

Taj Taal Kutir Convention Centre, adjacent to the Exhibition venue, has been blocked for 3 days from 6th to 8th November for 3 days Conference. Based on discussions with Taj, it is assumed that the 3 days Conference budget will increase substantially, in comparison with the expenditure for 9th AMC, which was held over 2 days only.

Dr. Chandra Shekhar Singh, Convenor of 10th IME, briefed the Council about the exhibition.

He informed that for 9th IME, the minimum guaranteed amount from M/s TAFCON was Rs.35 Lakhs, which was reduced from the normative 45 lakhs as a one-time exception, considering the Pandemic. However, due to very good participation, Rs.45 Lakhs was paid by M/s TAFCON as per MOU terms. The minimum guarantee this time has been thus raised to Rs.55 Lakhs. The Council agreed and advised the Honorary Secretary to sign the MOU with M/s TAFCON.

## **Discuss about Holland Memorial Lecture.**

President informed that he has talked with the Secretary, Ministry of Coal for delivering the 62nd Holland Memorial Lecture and he has agreed.

President requested Shri Peeyush Kumar to organise a 1-day event with Holland Memorial Lecture. Sri Kumar agreed and requested for a finalised date so he can book the venue.

President assured that he would talk to the Secretary, Ministry of Coal for a choice of dates (preferably Saturday). 29th April, 2023 Saturday was tentatively proposed by Honorary Secretary.

# Discuss about the MGMI Membership Drive.

Considering the number of applications received, it was commended by all and the President was congratulated for the success of the drive.

Chairman, Nagpur Chapter informed that about 30 applications have been handed over on 11th morning to Honorary Secretary with payment and on 12th, before the Seminar on "Best practices in Mineral Industry" organised by MGMI, Nagpur Chapter, further 70 applications will be handed over, making it 100 applications from Nagpur Chapter for now.

The Council unanimously congratulated the President along with the Chairman, Nagpur Chapter for such wonderful achievement. Shri Singh promised there will be more membership in time, considering so many Mining related companies, colleges and Organisations, like MECL, MOIL, IBM, VNIT are located in Nagpur.

President prodded every Council member to take an active part in membership drive setting a target of 3000 members, an increase of 1000 members from present strength of 2000 members.

# Discuss about the revival of Chapters of MGMI.

President and all others praised the performance of Nagpur, Odisha, Delhi and Hyderabad chapters. It was informed by Dr. A Sinha and Dr P K Mondal, Honorary Treasurer, MGMI, that Dhanbad Chapter had a meeting to choose Office bearers (Chairman, Secretary, etc.) and is gearing up for an event along with membership drive.

# Consider applications for membership and the membership position of the Institute.

There were 86 new and complete applications since the last Council, out of which the Council members unanimously agreed for 85 candidates.

Discussions arose regarding membership of a candidate, namely, Ms. Nandini Chakraborty who is associated with a company supplying FLP equipment to mines since several years and have been doing Research and Development on Flameproof electrical for usage in UG Mines. She has been an associate member since a long time and has now put in an application for upgrading herself to Life Member. She is now an MD with vast experience of 40 years in related industry. However, as per AOA of MGMI, she does not fulfil the eligibility criteria of educational qualification.

The Qualification of Members as given in Articles of Association in Page no. 7 was spelt out. It was explained that AOA needs to be modified suitably to consider her Life membership.

It was decided that a committee will be constituted in the next Council Meeting for review of the AOA in view of the above discussions.

A. Prof B B Dhar proposed to have a good website with all information about activities and presence in all social platforms like Facebook, Twitter, etc.

Honorary Secretary informed that the website www.mgmiindia.in now has far improved look with several Dynamic features, with comprehensive online membership application form and UPI payment facility. He requested Prof Dhar to kindly suggest specific issues needing improvement or advice on new items to be possibly added. There needs to be a dedicated person who will update or handle the social media accounts, including a Twitter handle.

President suggested appointing a paid PR agency to handle such social media professionally and requested Honorary Jt. Secretary to facilitate opening of a Twitter account for MGMI.

Honorary Secretary also informed the Council that initially for online payment for membership, Razorpay was selected by the Website handlers and the process was taken to an advanced stage, when RBI stopped a few payment gateway service providers from on-boarding new clients till security audit of the companies were completed and compliance established. Also, there were some negative issues with RazorPay that came out in the papers and it was decided to talk to some other reputed companies like PayTM, Cc Avenue, Easypay, RUpay etc. Accordingly, they had talked, with CCAvenue and is going ahead with the payment gateway company (Registered Company is known as Infibeam Avenues Limited).

The Council agreed to the proposal with a rider that account security should be primarily kept in mind.

B. Honorary Secretary informed the Council that based on recommendation of a Finance Committee; an advertisement was placed in 2 papers for the post of Executive Secretary. There were 179 applications, out of which 11 were shortlisted and called for interview.

6 candidates turned up and Sri Prasun Nag was selected on the basis of interview judged on pre-determined criteria parameters. The new incumbent will be on contract basis for the first year and the salary will be Rs.40,000/- per month.

## REPORT ON THE 9TH ASIAN MINING CONGRESS (4th and 5th April 2022)

The 9th Asian Mining Congress (9th AMC) organized by the Mining, Geological and Metallurgical Institute of India (MGMI) at the Biswa Bangla Convention Centre, New Town, Kolkata on 4th and 5th April 2022 was the latest milestone in a series of biennial events of Asian Mining Congress (AMC) and International Mining Exhibition (IME) since

2006. Central theme of the Congress was "Technological Advances in Mining Industry: Status and Challenges". The Congress witnessed a participation of nearly 400 registered delegates including executives, practicing engineers, planners, policy makers, equipment manufacturers, regulators, scientists, researchers and other professionals from various organizations from India and abroad, who shared expertise and broad experience, through lively and dynamic presentations and discussions. To encourage students' participation in the congress, students were supported to attend through subsidized registration costs. In spite of being organized at Asia level, it owes to its credit key note lectures from Norway and United States of America. The congress created a lot of excitement in the research fraternity, which was reflected in the form of over 75 abstracts and 50 full-length research papers received from all over the world. During the two-day conference there were 8 sessions and 52 papers were presented. The event was supported by funding from:

- Steel Authority of India Limited (SAIL)

- Oil and Natural Gas Corporation Limited (ONGC)

The congress took place over two days and featured the inaugural session and two plenary sessions on 4th April 2022 and 6 technical sessions, a panel discussion and the valedictory session on 5th April 2022. It also included networking coffee spaces. This congress was designed to provoke as much debate as possible and to obtain as many critical and constructive views from stakeholders. Each plenary and technical session consisted of a Session Chair, a Rapporteur and few speakers. The papers presented by the speakers were made available ahead of the congress

The Hon'ble Chief Guest **Dr. Anil Kumar Jain, IAS,** Secretary, Ministry of Coal, Government of India inaugurated the congress on 4th April 2022 at 10:00 AM. In his address, Dr. Jain raised many important issues being faced by the mining industry. He emphasized on better quality of minerals being produced and highlighted the emerging market of rating companies that assess environmental, social, and governance (ESG) risks and opportunities of investments globally. The President MGMI, **Shri P. M. Prasad,** CMD, CCL, Ranchi in his welcome address dealt upon the need for organizing the Congress. The Chairman, 9th AMC **Shri P. S. Mishra,** CMD, SECL presented the theme of the Congress in a lucid manner for the understanding of the audience. Theme of the 9th IME was introduced by **Shri Bhola Singh,** Chairman, 9th IME and CMD, NCL. It was followed by the address of the Guest of Honour **Shri M. Nagaraju, IAS,** Additional Secretary, Ministry of Coal, Government of India. **Shri Pramod Agrawal,** 

**IAS,** Guest of Honour and Chairman, Coal India Limited addressed the gathering of experts from the Industry, R&D Institutions and the Academia. The Souvenir and Abstract of the congress were released by the dignitaries and a vote of thanks was proposed by **Shri Ranajit Talapatra,** Honorary Secretary, MGMI. Luminaries and young professionals from the world of mining industries, research institutions, academics and business graced the event.

Soon after the Inaugural session, the first plenary session began.

# Plenary Session - I

Session Chair: Shri N. C. Jha, Past President MGMI

Five key note lectures were delivered in the Plenary Session – I. The first key note lecture was delivered by Prof S P Banerjee, Former Director In-charge, ISM, Dhanbad, India. Prof. Banerjee Spoke on the availability of minerals needed for a green energy transition in the world and the Indian context. The demand and availability of selected critical metals for green energy transition, both from the world and Indian context were discussed. Dr. Rabi Narayan Bastia, Padmashri presented the incredible journey of seismic from petroleum to coal and to minerals. He summarized that now, since, the exploration for coal and mineral deposits is moving to greater depths, application of seismic tools and techniques have to be used for deep and expensive exploration and borehole drilling. A key note lecture on processing of bauxite residue for the recovery of metal values was given by Prof. Suddhasatwa Basu, Director, CSIR-IIMT Bhubaneshwar and CSIR-CIMFR Dhanbad. The R&D efforts of CSIR-IMMT Bhubaneswar on the processing and utilization of bauxite residue were deliberated. Mr Roopwant Singh, IAS, MD, GMDC, Gujarat highlighted the present activities of GMDC and discussed about upcoming lignite blocks, opportunities for capital partners for limestone and silica sand, exploration agencies to unearth the vast multi-metal and REEs, EPC contractors for value addition and processing and lignite beneficiation technology partners, O&M operators for their thermal Power plants and customers for our vast Bauxite, Bentonite and Silica Sand reserves. Dr N. K. Nanda, past president, MGMI made a presentation on start-ups in mineral and mining ecosystem in India. It was summarized that start-ups in mining and mineral sectors can be the growth engine for the sector. Adoption of new technology, digitalization of mining process and outsourcing non-core activities to start-ups in large mines improve the productivity and enhance viability of new projects to meet the future mineral demand of the country.

#### Plenary Session - II

Session Chairs: **Dr. Amalendu Sinha**, Former Director, CSIR-CIMFR and **Shri M. K. Singh**, Executive Director (Coordination), Coal India Limited

**Dr. Leon Clarke,** Director of Decarbonization Pathways at the Bezos Earth Fund, USA threw some light on key characteristics of net zero energy systems in his key note lecture and **Dr Sukanta Roy**, Advisor, Ministry of Earth Sciences, Government of India

presented the challenges, results and perspectives of geophysical exploration of the Koyna (India) intra-plate seismogenic zone through scientific deep drilling to 3 km depth. The last key note lecture of tunnels, caverns and slopes in discontinua – a critical assessment of continuum analyses, GSI, Hoek-Brown and Mohr Coulomb, with focus on 'discontinuum analyses and geology' was of **Dr Nick Barton**, Norway, who summarized that joint and rock mass characterization for discontinuum models were needed if we were to return closer to reality. It was concluded that joint and rock mass characterization for discontinuum models were needed forcoming closer to reality.

# **Report on Capacity Assessment Seminar**

- During a meeting chaired by Secretary (Coal) on 27th September 2021, Coal India Limited (CIL) had been advised to organise a seminar on Capacity Assessment inviting all coal companies, CMPDI, and private sector for stakeholder consultations as per the directions of the Hon'ble Prime Minister.
- Subsequently, Ministry of Coal, vide file no. A-60/12/2021-ESTABLISHMENT dated 2nd November, 2021 requested CMD, CIL to organise this Seminar during the 9th International Mining Exhibition (IME), organised by the Mining Geological and Metallurgical Institute of India (MGMI).
- Accordingly CIL, in collaboration with MGMI, organised this event to assess stakeholders' capacity and preparedness required to meet the future coal demand, on 4th April 2022 from 3:00 PM at Biswa Bangla Convention Centre, Kolkata, by dedicating an entire session during the 9th Asian Mining Congress.
- The seminar was chaired by Shri M. Nagaraju, Additional Secretary to the Govt. of India, Ministry of Coal, and graced by Shri Anil Kumar Jain, Secretary, Govt. of India, Ministry of Coal the Chief Guest of the seminar, in the august presence of Shri Pramod Agrawal, Chairman, CIL, Shri B. Veera Reddy, Director (Technical), CIL, Shri P.M. Prasad, Chairman-cum-Managing Director, CCL/President, MGMI and other dignitaries from reputed organizations. The seminar was coordinated by Shri Achyut Ghatak, GM (Corporate Planning), CIL.
- Altogether eight senior officials from pan-India reputed organizations expressed their valuable views and shared innovative ideas to enhance overall preparedness, with the objective of catering to the requirements of achieving 1 BT coal production target, with special emphasis on wherewithal, equipment and roadmap to 1.5 BT production for the country as a whole.
- The enriching ideas also threw light on the wide gamut of elements of capacity, that definition-wise is the comprehensive ability of assets & resources to perform and enhancement of which leads to larger output, better economics and greater shock absorbing ability.

- NCL expressed that coal shall continue to remain the primary player in the energy mix of the country in coming years due to major drivers like Make in India, 24X7 power for all, Rise of e-mobility, rural electrification & sustained economic growth. With large capacity equipment (Draglines, Shovels & Dumper), efficient dispatch (through MGR, CHPs and Silos) and evacuation (mostly through MGR & Rail mode), NCL contributes significant share of overall production of CIL, with consistent growth. Well planned mechanization, standardization and capacity building with matching geo-mining condition has enabled NCL to achieve planned coal targets, improvement in production, productivity & safety, better environment management, flexibility in production system for quick response to dynamic market scenario, and has further strengthened the foundation for future plans towards optimum extraction of coal resources.
- **CMPDI** projected Skill Development of human resources as a necessary tool for achieving 1 BT production by 2024-25, by enhancing human resource capabilities in overall management of project, contracts, supply chain, operations and statutory clearances & compliances, through reskilling & upscaling of human resources. For smooth implementation of skill development, a structured approach was proposed in the form of Talent Management Policy, which harnesses leadership abilities of potential executives & readiness to assume critical responsibilities. Towards capacity enhancement, need-based training of existing & newly recruited executives is required with focus on future thrust areas like IT application, enhanced production from UG mining, mass production technology, indigenization of technology, digitization & techno-managerial leadership improvement, so as to analyse, identify and redress likely impediments & constraints in enhancing coal production. CMPDI has taken up some reskilling/upskilling activities like training in latest software, training of geologists in other areas, thrusts on diversification initiatives etc. IICM can be upgraded to spearhead skill development initiative, by remodeling it into a dynamic centre of excellence. Skill development of both upper & lower levels of workforce would lead to cope with the automation and mechanization being planned in mining operation and maintenance activities.

- In their pursuit towards capacity enhancement, **DVC** has taken up diversification in a large way into solar power and coal mining to fulfill the needs of its assets.
- BEML stressed more & more on R&D activities as a successful tool for capacity enhancement, which have aptly delivered India's largest indigenous mining trucks 150 Te and 205 Te payload carrier Electric Drive Dump Trucks. High capacity Rope shovels & backhoes, hydraulic excavators, walking draglines, dozer, tyre handlers etc. are being manufactured for coal sector. Launching of 240 Te Electric Drive Dump Trucks is in pipeline. Al &loT projects like Vehicle Health Monitoring System, Al based predictive maintenance through data analytics & telematics, Al based 360° surrounding view monitoring system, Drivers Fatigue Monitoring System, Payload Monitoring System etc. are being introduced in equipment for better safety & health management and greater productivity improvement.
- SCCL showcased its pioneering initiatives in implementation of ERP-SAP system, commissioning largest capacity longwall project, production of thermal power & solar power and adopting sand processing plant using OB. With limited reserves amenable for OC mining, SCCL has converted a number of UG mines to OC for augmenting production. SCCL deploys Shovel Dumper combination, In-Pit crushing & conveying, Surface Miner in the OC mines and Longwalls, Continuous Miners and LHDs & SDLs in the UG mines. Future plans of SCCL towards capacity expansion include new mining projects within & outside Telangana state, upcoming CHPs, new railway infrastructure construction and Diversification initiatives like existing Thermal power plant (installed capacity 2X600 MW), Solar power plants (300 MW by '22), Floating Solar power plants (250 MW by '22-'23), capacity expansion of explosive manufacturing plants and processed OB plants.
- NLCIL, the largest OC lignite mining CPSE in Asia and nodal agency for lignite mining in India, emphasized on strong in-house capabilities in its core business of diversified & integrated lignite mining, coal mining, power generation and power trading, leading to doubling of mining capacity & 50% increase in power generation capacity in last 3 years. As a part of Vision 2030, NLC has envisaged to enhance both its coal and lignite mining capacity and expansion of power generation capacity, both in thermal & renewables like solar & wind. In its constant endeavour towards capacity enhancement, NLC intends to foray in areas of potential business opportunities like allied areas in power sector, EV charging infrastructure, application of AI, commercial coal mining, lignite blending and diversification initiatives like solar wafer manufacture, lignite to methanol, lignite to diesel, lignite to hydrogen and waste to wealth efforts like OB to sand & minor minerals.
- SAIL highlighted the fact that dearth of indigenous coking coal has led to major import of the same & resultant blending. In its bid to enhance its capacity to 50 Mty by 2029-30, the projected Prime coking coal requirement is also likely to be

considerably higher to about 100 Mty. Accordingly, the projected import of high-quality low ash coking coal shall increase steeply. The option of blending with the indigenous coal may also be thought of.

- To keep pace with the need of the industry and facilitate the coal sector to achieve
  1.5 bt aspirational target, GMMCO provided details of various manufacturing
  capacities and the capacity expansion programs. It was remarked that currently
  GMMCO has a major export market and has the capability to look inwards if
  demand arises.
- The seminar was followed by an informative Q&A session & concluded with vote of thanks to the Chair.
- The seminar was successful in that it brought out some extremely innovative thoughts & ideas for overall improvement in Capacity Assessment and Enhancement through R&D, better industry interface and more investments for 'Make in India' for achieving the aspirational target of 1.5 BT coal production nationwide, thereby contributing to the energy security of the nation and making the country 'Atmanirbhar' in the days to come.
